Our Mission

The mission of LDA Minnesota is to empower and support children, adults, families and the broader community impacted by learning disabilities, attention deficits and related challenges through assessment, intervention, education, and outreach.

Our Work

One in five individuals have a learning challenge, whether it's a learning disability, ADHD, or other learning difference. Others impacted by poverty and lack of access to early childhood education may also struggle with learning.

LDA Minnesota works to serve all of these populations through our programs and services, using best practices for individuals who learn differently. There is a **spectrum of learning challenges**, from severe processing challenges to a late introduction to sounds and words. Depending on where individuals fall on this spectrum, LDA uses interventions and services tailored to each individual's needs.

By the Numbers

- 3,241 children and adults were served in FY2015
- Of those, 81% were children and families and 19% were adults
- 80% of those served were low-income or living in poverty
- 74% of those served were people of color
- 5,013 books were donated to LDA and distributed to low-income kids

FY2015 Program Results

Learning Connections program

The Learning Connections program provides:

- Intensive reading, writing and math small group instruction for low-income K-12 students, resources for classroom teachers, and support for their parents.
- Preschool emerging literacy book bag exchange program and teacher training in partnership with early childhood programs.
- Distribution of quality books to children in low- income communities.
- Family events designed to provide parents with fun literacy activities to reinforce learning at home.

Assessment and Tutoring services

Assessment and Tutoring Services include:

- Diagnostic assessments for learning disabilities or ADHD
- Tutoring and Executive Function Skill Building to assist children, youth, and adults in improving their learning strategies and skills to meet their academic, vocational, and personal goals
- Individual consultations to help individuals better understand their learning challenges and how to overcome them

Transition Services

Transition Services helps high school youth and young adults plan and implement successful transitions from high school to the world of work or post-secondary education. During 2014-2015, LDA delivered its Transition program at Bethel University to 10 students in collaboration with the Autism Society of Minnesota.

LD & ADHD Support Services

Learning Disability and ADHD Support Services include monthly support groups, symposia, workshops, and professional training. These services provide useful information and strategies to help manage LD and ADHD in the classroom, home, work and community.


